5. Discussion of Trent proposals for change in RC33 organization.

7. Discussion of future activities.

Inter-congress activities

• Luciana Ghiga informed about the possibility of organizing a conference in Romania in 2013/2014 on the state of political science, how we can develop the profession a bit more, etc. NB: at the moment, Romania has two dead political science associations. There will be a meeting this September to try and create a third one ("Romanian political studies association"). At the moment, 95 people would be interested.

• Cecilia Lesgart informed about the panel on the history of political science in Latin America at the Argentinian political science congress next year. This panel could be organized also as a RC meeting.

• John Trent told about previous attempts to organize a conference on political science in the Arab world. During the Madrid Conference, Clement M. Henry (The American University in Cairo) was interested in doing something about this. Erkki Berndtson is to contact Henry and the new RC Executive Committee member Bahgat Korany, to find out about different options.

• Bob Reinalda suggested that the RC would try to organize a meeting on Russian political science. John Trent informed that the new RC Executive Committee member Olga Malinova was interested in setting up a meeting on the subject. Erkki Berndtson is to contact Malinova.

Discussion of panels for 2014 congress

The following topics were proposed for the 2014 Congress:

• Towards a new political studies (John Trent).

• Academia and politics: how politicians can use academia to get positions, how administration shifts the interests of science (Luciana Ghica).

• Assessment of relations between subdisciplines: bring together representatives from different IPSA Research Committees (Erkki Berndtson).

- How politicians see politics (Pere Vilanova).
- Fragmentation of political science (Pere Vilanova).
